Subject: Care homes for older people

Further to my email of 4 April 2018, I have considered your request for a review in which you explained that you were dissatisfied that the Council had failed to provide you with a response within the required statutory timeframe. Having carried out a review in accordance with the provisions of the Freedom of Information (Scotland) Act 2002 ("FOISA"), I can confirm that your appeal was successful.

I wish to apologise that you did not receive your response within the required 20 working days. The information requested is enclosed below.

- Q1. The total number of care homes in Scotland currently owned by the Council at today's date (15 February).
- A1. The total number of care homes currently owned by the Council is nine.
- Q2. Please provide a note of the following details in relation to each care home in Scotland currently owned by the Council:
- a. name of each care home (if applicable);
- b. full postal address of each care home;
- c. confirmation as to whether the Council operates each care home or whether any care homes are operated by a third party for and on behalf of the Council, and if the latter, the full name and postal address of any such third party(ies); and d. the total period of ownership by the Council of each care home, such period of time to be specified in years and months.

The total costs incurred by, and for and on behalf of, the Council (such costs to be calculated from the beginning of ownership by the Council of each care home to today's date (15 February)), associated with the following (such total costs to be broken-down and provided to us on a per care home basis):

We have also included information on holiday entitlement.

We do not hold the information on 'average sick pay'. Unfortunately we should have sought clarification regarding the period that you would be seeking the average sick pay to be calculated for. We would then be in a position where we could determine if the information you are seeking could be extracted from the relevant systems.

We have identified the councils current contribution to superannuation, however this will have changed over the period requested and information on these changes would have to be sought from the Lothian Pension Scheme. Please contact them by clicking on the following link for this information:

- b. the total expected and budged costs for the Council of each of the aforesaid care homes (such total costs to be broken-down and provided to us on a per care home basis).

A18. There is no intention at this point to buy, develop or build in the future.
