Thank you for your recent enquiry under the Freedom of Information (Scotland) Act 2002 in respect of Care Homes for older people as registered with the Care Inspectorate. I have responded directly to yourself by email as directed within the correspondence from [REDACTED].

As of today's date East Dunbartonshire Council does not own any care homes for older people and does not hold any care homes for older people under lease or other tenancy right. Within East Dunbartonshire Council area all of the care and nursing homes for older people are privately owned and run. This has been a longstanding position and in terms of questions one to seventeen as there are no council owned care homes for older people the response would be a nil return. In response to question eighteen I can advise that the council currently has no plans to buy, develop or build any care homes for older people.

I trust that this response has provided the information requested, however if you are unhappy with the information provided by East Dunbartonshire Council in response to your request; you are entitled to require the Council to review its decision. Please note that in order for a review to take place you must:

- Lodge a written requirement for a review within 40 working days of the date of this letter
- Include a correspondence address and a description of the original request and the reason why you are dissatisfied.
- Address your request to the Freedom of Information Officer:

The review will be handled by staff who were not involved in the original decision. You will receive notice of the results of the review within 20 working days of receipt of your request.

The notice will state the findings of the review as well as details of how to appeal to the Scottish Information Commissioner if you are still dissatisfied with the Council's response. You must request an internal review by the Council before a complaint can be directed to the Scottish Information Commissioner.

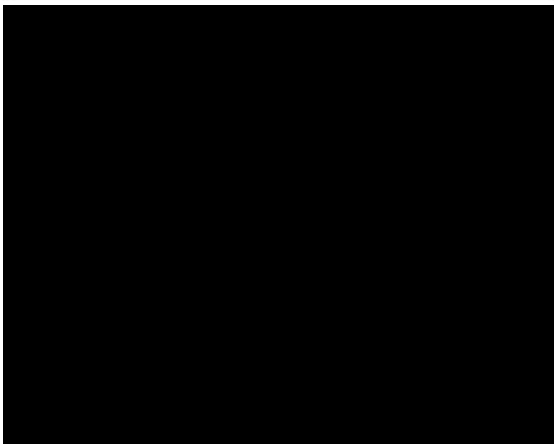

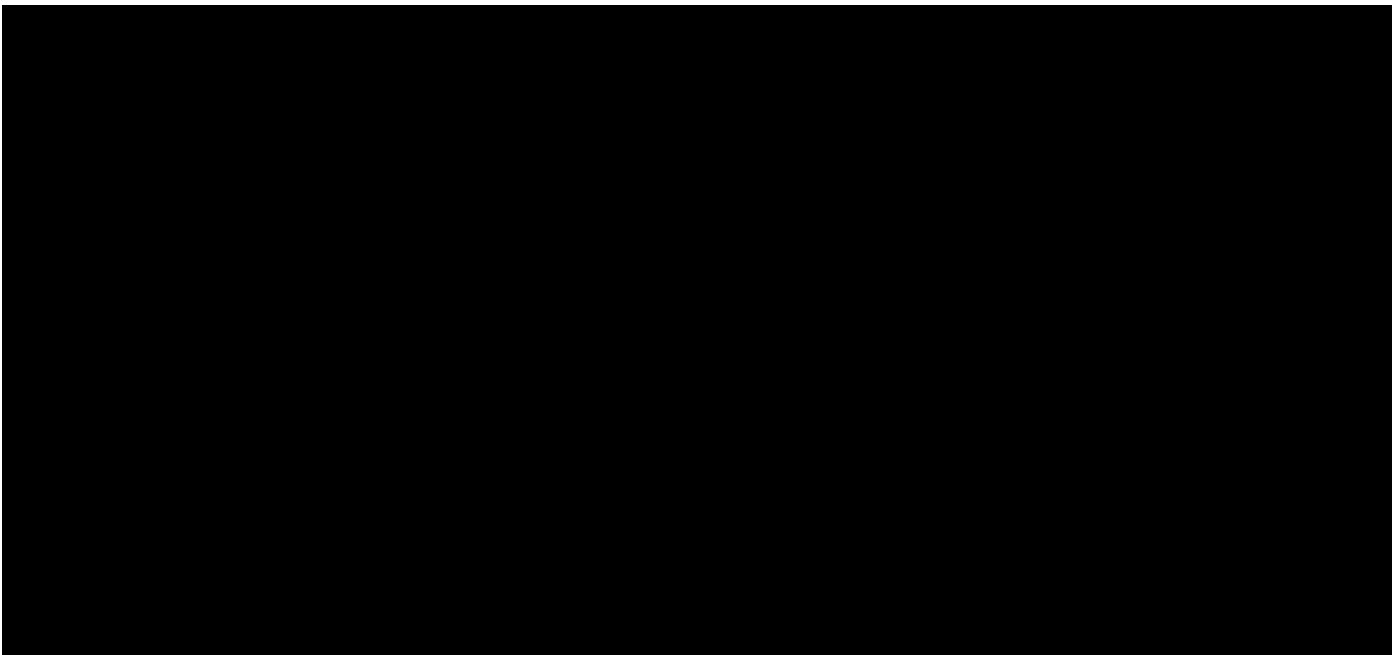
