Further to your Freedom of Information Enquiry to East Renfrewshire Council please find detailed below our response.

- a) Bonnyton House if the only care home operated by East Renfrewshire and is owned by the Council ;
- b) The current outstanding loan debt in respect of Bonnyton House as at 31 March 2018 is £1.050m ; it would not be possible from records within the HSCP to identify previous construction costs in regards Bonnyton incurred over 20 years ago;
- c) Detailed costings as highlighted in previous reports to Integration Joint Board , report of 29 November 2017 provides and links to previous background papers;
- d) Am not aware of any plans for ERC to buy or build a care home but is planning to develop Bonnyton into a centre of excellence for older people including developing a six bed intensive rehab resource to prevent unnecessary hospital admissions and to create a new six bed unit for palliative and end of life care.
