*When we refer to privately funded residents we are referring to those residents who are assessed as having capital above the upper limit of £27,250 (and excluding any entitlement to free care). Please provide the requested information on a per care home basis.*

**Response**

Relative to the above, I am advised that the weekly charge for all care homes is £903.41. If any clients are entitled to free personal care it will cost £903.41 less £174.
